THIRD
PROCEDURAL ORDER

14 BY THE COMMISSION:

15 On September 18, 2008, the Securities Division ("Division") of the Arizona Corporation
16 Commission ("Commission") filed a Temporary Order ("T.O.") and Notice of Opportunity for
17 Hearing ("Notice") against Jerome William Carter dba Good Only Done Productions, L.L.C.,
18 ("GOD") and Jane Doe Carter, husband and wife, and The Greatest Only Divine Productions, L.L.C.
19 ("GODP") (collectively "Respondents") in which the Division alleged multiple violations of the
20 Arizona Securities Act ("ACT") in connection with the offer and sale of securities in the form of
21 commodity investment contracts and/or investment contracts.

22 The Respondents were duly served with copies of the T.O. and Notice.

23 On October 15, 2008, a request for hearing was filed by the Respondents.

24 On October 17, 2008, by Procedural Order, a pre-hearing conference was scheduled on
25 November 17, 2008.

26 On November 17, 2008, the Division and Respondents appeared with counsel. The Division
27 has subpoenaed documents from Respondents and the parties are discussing issues raised in the T.O.

1 and Notice. The Division requested that a status conference be scheduled in approximately 45 days.


2 On November 17, 2008, by Procedural order, a status conference was scheduled for January
3 26, 2009.

4 On December 9, 2008, the respective counsel for the Respondents filed an Application to
5 Withdraw as Counsel ("Application") pursuant to ER 1.16(b). Counsel have notified Respondents of
6 the status conference which was previously scheduled for January 26, 2009, at the Commission's
7 offices in Phoenix, Arizona. Counsel also provided the Commission with Respondents' present
8 mailing address.

9 Accordingly, the Application should be granted.

10 IT IS THEREFORE ORDERED that the Application to Withdraw as Counsel is hereby
11 granted.


