PROCEDURAL ORDER


The Applicant has filed on December 16, 2008, a Notice of Filing that incorporates a draft form of Certificate of Environmental Compatibility ("CEC") intended to incorporate the decision of the Arizona Power Plant and Transmission Line Siting Committee of December 2, 2008, in this matter. The Notice indicates the proposed form of CEC was filed for the review of the intervenors and to provide the opportunity for the submission of any suggested revisions. John Foreman, designee of the Attorney General of Arizona, Terry Goddard, as Chairman and Presiding Officer of the Arizona Power Plant and Transmission Line Siting Committee as authorized by A.R.S. §§ 40-360.01(C) and (D), 40-360.04 and A.A.C. R14-3-201(E), issues the following procedural order,

IT IS ORDERED:

1. The parties shall file with docket control of the Arizona Corporation Commission in the above numbered matter any response or suggested revisions to the draft CEC and this Order on or before December 26, 2008.
2. A copy of any revision or response filed pursuant to this Order shall be served upon the Chairman by hand delivering, on the day the original is filed, a copy at his office at 1275 W. Washington, Phoenix, Arizona.
3. The Chairman will consider the proposed CEC and any response or suggested revision on December 29, 2008.
4. It appears that December 29, 2008, will be the last day upon which the Committee may file its written decision pursuant to A.R.S. § 40-360.04(D), R 14-3-213 and R14-3-215, Rules of Practice and Procedure Before the Power Plant and Line Siting

1 Committee. No written objection was filed by any party to the determination in the
2 Procedural Order of July 2, 2008, finding that December 28, 2008, was the 180th day
3 after the filing of the Application in this matter. Because December 28, 2008, is a
4 Sunday, the Chairman concludes December 29, 2008, is the last day for Committee
5 action.


