NOTICE OF FILING STAFF'S CLARIFYING COMMENTS TO RECOMMENDED OPINION AND ORDER

Arizona Corporation Commission ("Commission") Utilities Division Staff ("Staff") generally supports the Recommended Opinion and Order ("ROO") in the above-captioned matter that was issued by Administrative Law Judge Marc E. Stern on December 23, 2008, and believes the proposed order reflects the appropriate disposition of this case. There are, however, several statements in the ROO that Staff believes do not accurately recite the evidence in the record as presented at hearing; therefore, Staff offers these clarifying comments.

At page 8 of the ROO, the ordering paragraph that begins on line 1 lists Lake Verde Water Company as a Non-filing Respondent. Staff would clarify that, consistent with the information in Staff's exhibit S-2 in the record, and with finding of fact 3 on page 3 of the ROO, and with the ordering paragraph on page 6 at line 26 of the ROO, Lake Verde Water Company actually late-filed its annual report. Therefore, Staff recommends that "Lake Verde Water Company" be deleted from the ordering paragraph on page 8 at line 2.

Consistent with the information in Staff's Exhibit S-4, filed in this docket on November 18, 2008, and with finding of fact 12 on page 5 of the ROO at lines 17 to 19, Green Acres Water Company, Hopeville Water Company, and Strawberry Water Company late-filed their annual reports. However, Staff would clarify that these three companies were inadvertently omitted from the proposed order. Therefore, Staff recommends that "Green Acres Water Company," "Hopeville
