STAFF'S CLARIFYING EXCEPTION TO THE RECOMMENDED OPINION AND ORDER

On December 23, 2008, the Arizona Corporation Commission ("Commission") Hearing Division issued a Recommended Opinion and Order ("ROO") in the above-captioned matters. Commission Utilities Division Staff hereby provides a recommended clarification to the ROO.

Page 9, line 18 of the ROO states that Yarnell Water Improvement Association, Inc. should "file a copy of the notice sent to its customers with the Compliance Section of the Utilities Division". Staff believes that such notice should be filed instead with Commission Docket Control.

As such, Staff recommends that on page 9, line 18 of the ROO, the words "Compliance Section of the Utilities Division ("Compliance Section")" should be removed and replaced by the words "Commission's Docket Control".


