13 **BY THE COMMISSION:**

14 On October 10, 2008, the Securities Division ("Division") of the Arizona Corporation  
15 Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Mark A.  
16 Westerfield and Victoria H. Westerfield, husband and wife, formerly doing business as Builder's  
17 Secret ("Secret") (collectively "Respondents") in which the Division alleged multiple violations of  
18 the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of  
19 investment contracts.

20 The Respondents were duly served with copies of the Notice.

21 On January 2, 2009, a request for hearing was filed by the Respondents.

22 Accordingly, a pre-hearing conference should be scheduled.


23 **.IT IS THEREFORE ORDERED** that a **pre-hearing conference** shall be held on **February**
