PROCEDURAL ORDER

11 **BY THE COMMISSION:**

12 On November 5, 2008, the Securities division ("Division") of the Arizona Corporation  
13 Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and Notice of  
14 Opportunity for Hearing ("Notice") against Gerald Edward Patchen II and Jane Doe Patchen,  
15 husband and wife (collectively "Respondents"), in which the Division alleged multiple violations of  
16 the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of  
17 notes.

18 Respondents were duly served with copies of the Notice.

19 On November 28, 2008, Respondents filed a request for hearing.

20 On December 8, 2008, by Procedural Order, a pre-hearing conference was scheduled on  
21 January 20, 2009.


22 On January 20, 2009, at the pre-hearing conference, counsel for the Division and Respondent,  
23 Mr. Patchen, appeared and discussed issues related to the T.O. and Notice. The parties further  
24 discussed the scheduling of a hearing on the issues raised in the T.O. and Notice.

25 Accordingly, a hearing should be scheduled on the allegations contained in the T.O. and  
26 Notice.

27 IT IS THEREFORE ORDERED that a hearing shall be held on April 30, 2009, at 9:30 a.m.  
28 at the Commission's offices, 1200 West Washington Street, Commissioners' 2<sup>nd</sup> Floor Conference  
Room, Phoenix, Arizona.

1 IT IS FURTHER ORDERED that the parties shall **exchange copies of their Witness Lists**  
2 **and copies of their Exhibits by March 30, 2009**, with courtesy copies provided to the  
3 Administrative Law Judge.
