PROCEDURAL ORDER

BY THE COMMISSION:

On August 11, 2008, Arizona Public Service Company ("APS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for the sale and transition of certain facilities in Pinal County pursuant to A.R.S. § 40-285(A) and for deletion from its Certificate of Convenience and Necessity ("CC&N") from certain areas of Pinal County.

On August 13, 2008, the Electrical District No. 3 of Pinal County ("ED3") filed an application to intervene in this proceeding.

On September 12, 2008, by Procedural Order, ED3's application to intervene was granted.

On October 31, 2008, the Commission's Utilities Division ("Staff") issued a letter stating that the Company had met the sufficiency requirements in this matter.

On January 5, 2009, APS filed Joint Transition Plan of APS and ED3 and Requests for Waiver of Certain Rules Pursuant to A.A.C. R14-2-212(I) and Specific Language to Effectuate Such Plan.

Accordingly, a procedural conference should be held to discuss the procedural schedule for this matter.


