

Dear Parties of Record:

Having received and reviewed the filed testimony of Commission Staff and Interveners, Arizona Public Service Company (“APS” or “Company”) believes that settlement of this case may be possible and would like to engage in settlement discussions with all parties. Accordingly, APS invites all parties to attend settlement discussions on Friday, January 30, 2009¹ at 10:00 a.m. at the Second Floor Conference Room at the Offices of the Arizona Corporation Commission.² Although the Company is not requesting a suspension of or delay in the current procedural schedule at this time, it is likely that APS will seek such a suspension or delay subsequent to the January 30th meeting should sufficient parties indicate an interest in at least discussing settlement.

This first settlement meeting will include a short presentation by APS, feedback from the parties, and consideration of a structure and/or topics for subsequent settlement discussions. A second settlement meeting has been tentatively set for Thursday, February 5, 2009 at 10:00 a.m. at the same location as the first meeting. APS would ask that parties keep that time and date open.

Parties who cannot attend in person either or both of these meetings are encouraged to participate telephonically. If you wish to so participate, please contact me prior to the meeting and appropriate arrangements will be made. Please also contact me should you have any questions about this Notice.

¹ This date is more than three (3) business days following the Notice of Settlement Discussions, per ACC policy.

² Both the first and second settlement meetings are scheduled until 5:00 p.m., although they may end prior to such time if the parties believe they have accomplished all they can for the day.
