We as bonifide land owner residents of Beaver Dam, Arizona, and customers of Beaver Dam Water Company, are very concerned about the proposed request for an increase in water rates and charges for our Beaver Dam area.

Beaver Dam Water Company had requested a Grant to update or improve on their water system a few years ago. And they received it. It was assumed that this was to take care of the proposed residential housing development, being planned for this area. As well as an upgrade on the existing water lines and storage facilities for this proposed future growth. The expected growth, in part, did not transpire, due we're sure, to the economic crisis that has developed world wide.

Beaver Dam Water Company will not have the funds they have enjoyed in the past due to this slow down in the economy.
