
Docket Nos. E-01032C-98-0474 and E-01032C-97-0774 relate to the A.C.C.'s consideration of Stranded Cost Recovery and Unbundled Tarriffs. On July 3, 2003, in Decision No. 66028, the Commission approved the sale of assets and transfer of Citizens' CC&N. As a result, Citizens no longer provide electric service in Arizona.

Per the Procedural Order issued on March 23, 2009, by Jane L. Rodda Administrative Law Judge, these docket numbers should be administratively closed. Therefore, these docket numbers are administratively closed.


