Dear Corporation Commissioners and Staff:

Enclosed please find an original and thirteen copies of the tariff filing for Citizens Utilities Rural Company, Inc. d/b/a Frontier Citizens Utilities Rural (Frontier) for review and approval.

The purpose of this filing is to reduce the monthly charge for the Frontier Digital Phone Essentials bundle, remove the reference to the non-regulated 100 long distance minutes and the special condition that required customers to designate FCA as their long distance provider. Existing customers that subscribe to FCA will continue to receive the 100 LD minutes in accordance with the rates and terms defined in Frontier Communication of America's domestic price list.

It is respectfully requested that this tariff become effective on May 24, 2009.

15.10 FRONTIER DIGITAL PHONE ESSENTIALS

15.10.1 Applicability

Applicable to Single-party Residential Flat rate service.

15.10.2 Territory

Applicable to the territory within the exchange areas where service is provided from Central Offices and/or Operating Systems capable of providing the Frontier Digital Phone Essentials bundle as said exchanges are defined on the maps contained in this tariff.

15.10.3 General

A. Frontier Digital Phone Essentials is a bundled offering available to Residential customers that subscribe to flat rate service. The bundle includes the following components: one basic Flat Rate Access Line, Touch Calling and a combination of local features. Customers may select any or all of the following services and features for a monthly rate charge.
