17 Intervenor Town of Florence, by and through its attorney undersigned, hereby requests an
18 extension of time to file its testimony and any associated exhibits.

19 On August 15th, a procedural order was issued directing intervenors to file testimony and
20 exhibits on or before February 4, 2009.

21 However, intervenor Town of Florence did not file its Motion to Intervene until
22 undersigned counsel received authorization from the Florence Town Council on December 15,
23 2008. While the reasons for this are several, it is respectfully urged that as a body corporate and
24 politic, the Town of Florence cannot make decisions with the same rapidity as a private
25 corporation. Consequently, the Town anticipates that it will not have the opinions of its witness
26 on or before the deadline for filing.

27 If the court grants intervenor's motion, the Town of Florence will stipulate that any
28 response required to be filed by applicant Johnson Utilities, LLC may, at the discretion of the
court, be extended a like amount of time.




