22 **STAFF’S REQUEST FOR CONTINUANCE**

23 Pursuant to procedural order filed on October 21, 2008 in the above captioned matter, various
24 filing deadlines for the affected parties were set. Arizona Water Company (“AWC”) and various
25 Global Water entities (“Global”) were required to, and did file testimony on January 12, 2009.
26 Arizona Corporation Commission (“Commission”) Utilities Division Staff (“Staff”) is required to file
27 responsive testimony on February 2, 2009. In the intervening days since AWC and Global filed
28 testimony, a number of factual issues have developed which Staff believes can be resolved through
discovery processes. However, due to the relatively short interval between the filing of AWC and
Global testimony before the filing of Staff testimony, Staff will not have adequate time to pursue
these issues sufficiently to make a recommendation within the allotted time.

Among the issues that Staff has encountered are new requests for service within the Global
Water requested extension area. Staff would like to develop additional information as to the location
and proposed facilities that would be serving these additional areas. Likewise, Staff has questions
with respect to on-site facilities for the service of the areas within AWC’s requested extension area
for which there are requests for service. Additionally, Staff would like to develop additional
information concerning the financing of plant that needs to be constructed to serve the extension
areas.

1 While sufficient time to perform even a single round of additional discovery would likely
2 jeopardize the existing schedule, Staff anticipates that some of the materials responsive to Staff's
3 concerns may take substantially longer time to develop than others. In consequence of that
4 consideration Staff requests at least a 60 day extension of its filing deadline. Staff and parties
5 discussed this request as well as additional schedule changes necessary to accommodate the request
6 during a telephonic conference with Administrative Law Judge Dwight Nodes. Based on parties'
7 likely availability, Staff requests that the filing date for Staff's testimony be moved to April 10, 2009.
8 AWC's and Global's rebuttal testimony would be filed on May 8, 2009. The date for the first day of
9 hearing would be moved to June 8, 2009.


