

PUBLIC NOTICE OF AN APPLICATION  
FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY  
BY Kings Ranch Water Company

Kings Ranch Water Company has filed with the Arizona Corporation Commission ("Commission") an application for authority to provide water utility services to an area which records indicate that you are a property owner. If the application is granted, Kings Ranch Water Company would be the exclusive provider of water utility services to the proposed area. Kings Ranch Water Company will be required by the Commission to provide this service under the rates and charges and terms and conditions established by the Commission. The granting of the application would not necessarily prohibit an individual from providing service to themselves from individually owned facilities on their property. The application is available for inspection during regular business hours at the office of the Commission in Tucson at 400 West Congress, North Building, Room 218 and at the offices of the applicant's legal counsel, Michael F. McNulty, Lewis and Roca LLP, One South Church Avenue, Suite 700, Tucson, Arizona 85701.

The Commission will hold a hearing on this matter. As a property owner you may have the right to intervene in the proceeding. If you do not want to intervene, you may appear at the hearing and make a statement on your own behalf. You may contact the Commission at the address and telephone number listed below for the date and time of the hearing and for more information on intervention. You may not receive any further notice of the proceeding unless requested by you.
