13 On December 15, 2008, Pine Water filed a second request for modification to file  
14 rate case. On January 28, 2009, the Utilities Division filed a memorandum recommending  
15 that "the Commission deny Pine's request to vacate the requirement to file a rate case by  
16 June 1, 2009, and instead, order that the date for the rate case filing be extended to June 1,  
17 2010, using a 2009 test year." Under the circumstances, Pine Water accepts this  
18 recommendation and respectfully requests that an order be issued extending the deadline  
19 for Pine Water to file a rate case no later than June 1, 2010, using a 2009 test year.
