Re: Request for the Commission in Its Public Service Corporation Regulatory Capacity to Take Notice of the Conversion and Change of Name of Qwest Communications Corporation to Qwest Communications Company, LLC, and to Amend the Commission's Records Accordingly

Dear Mr. Kearns:

Qwest Communications Corporation secured Certificates of Convenience and Necessity ("CC&Ns) in the State of Arizona as a facilities based provider and reseller of interexchange telecommunications services, and as a facilities based provider and reseller of competitive local exchange services, pursuant to orders of the Arizona Corporation Commission (the "Commission"). Those orders were approved in Commission Decisions Nos. 66612 and 68447. On January 2, 2009, Qwest Communications Corporation, a business entity organized under the laws of the State of Delaware, converted to Qwest Communications Company, LLC ("QCC LLC"). QCC LLC is the same legal entity as Qwest Communications Corporation. QCC LLC requests that the Commission take notice of this change, and amend its records to reflect that Qwest Communications Company is now Qwest LLC.

QCC LLC is filing notice of this request in Docket Nos. T-02811B-01-0895 and T-02811B-04-0313 (the CC&N dockets). Only a name change of the holder of the CC&Ns is necessary. No transfer of the CC&Ns is required because QCC LLC is the same legal entity as Qwest Communications Corporation.

The conversion of Qwest Communications Corporation to Qwest Communications Company LLC does not result in any changes to operations, company employees, services, or rates. The company has already amended its tariffs to reflect the name change. Those filings were made in Docket Nos. T-02811D-08-0602 and T-02811D-08-0603.

Copies of the Delaware Certificate of Conversion are available upon request. QCC LLC has registered in the State of Arizona as a foreign limited liability company, and copy of the certificate of the Commission is available upon request.
