that requests a 300 per cent revenue increase are questionable and should be subject to an independent audit of its operation, management methods and financial record keeping.

As a party currently being served by Far West, I request the current application be dismissed without further action and an independent audit completed at the cost of Far West. The audit information should then be made available to the public in the area serviced by Far West and the Commission for a period of time sufficient to permit an adequate review of the same. If the audit indicates the management and operations of Far West are comparable to similar types of operations, a new rate increase application could then be considered during appropriate public hearings, the approval of which could include management and operational changes deemed necessary, the amount of any increase proven necessary by the audit and the period of time over which the increases could occur. If the audit indicates otherwise, the operations of Far West should be taken over by the Commission and run as a public utility.


