To Whom It May Concern;



Far West Water and Sewer Co. (FWWS) submitted an application to the Arizona Corporation Commission claiming an "emergency" rate increase is necessary to keep them solvent. FWWS customers oppose this increase as it does not constitute an emergency and was brought on by a chronic history of violations culminating in their current crises. There was no "sudden change" as quoted by the company using "Op. Att'y Gen. 71-17 at 13," but rather a disregard for regulations, which likely resulted in abnormally low operating costs and may have exposed the public to hazardous conditions. Whereas proper compliance should have resulted in facility expansions paid for by each new development with appropriate maintenance and upgrade costs resulting in rates similar to compliant facilities. FWWS customers are not responsible for the company's crises. Approving the increase would reward the company's misconduct and may result in unacceptable financial hardship to its customers.
