PROCEDURAL ORDER

BY THE COMMISSION:

On February 18, 2009, the Securities division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and Notice of Opportunity for Hearing ("Notice") against Steve John Rogan, Carol Ann Richey, husband and wife, Dem Bonz Barbeque Restaurants, L.L.C. ("Dem Bonz") and Pizazz, L.L.C. ("Pizazz") (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of notes and for investment contracts.

The Respondents were duly served with a copy of the Notice.


On February 24, 2009, a request for hearing was filed by the Respondents.
