REQUEST REGARDING
DEADLINE FOR FILING
REBUTTAL TESTIMONY TO
SWING FIRST GOLF DIRECT
TESTIMONY**

At the procedural conference held February 26, 2009, in the above-captioned case, the parties discussed with the administrative law judge a revised procedural schedule for Swing First Golf, LLC, ("SFG") to file replacement direct testimony and for Johnson Utilities, LLC, ("Johnson Utilities" or the "Company") to file rebuttal testimony to the SFG testimony. At the procedural conference, counsel for Johnson Utilities agreed that the Company's rebuttal testimony to the replacement direct testimony of SFG would be filed Friday, March 20, 2009. However, lead counsel for Johnson Utilities will be out of town the week of March 16-20, 2009, and therefore requests that the Company's deadline for filing rebuttal testimony to the SFG replacement direct testimony be extended to Monday, March 23, 2009. Counsel for Johnson Utilities has notified the other parties in this proceeding of this request, and no party has raised any objection.
