12 By Procedural Order dated January 27, 2009, a Procedural Conference for the purpose of
13 determining the status of settlement negotiations was scheduled in the above-captioned matter for
14 March 2, 2009.

15 On February 26, 2009, Arizona Electric Power Cooperative, Inc., Sulphur Springs Valley
16 Electric Cooperative, Inc., Trico Electric Cooperative, Inc. and Mohave Electric Cooperative, Inc.
17 filed a joint request to continue the Procedural Conference as they are close to reaching an agreement
18 to resolve this complaint.


