



On July 1, 2008, Arizona Public Service Company ("APS") filed an application for a Certificate of Environmental Compatibility ("CEC") authorizing the TS-5 to TS-9 500/230kV Transmission Line Project (the "Project") in Maricopa County, Arizona. The Arizona Power Plant and Transmission Line Siting Committee ("Committee") held public hearings for the purpose of receiving evidence and deliberating on the application and, on December 29, 2008, issued a CEC for the Project. Several parties to the proceedings before the Committee, have filed Requests for Review asking the Arizona Corporation Commission ("Commission") to modify the CEC issued by the Committee or to reverse the Committee's decision and deny APS's application.

The Commission will hold a public comment session on this matter beginning March 2, 2009, at 10:00 a.m. at the Commission's offices, 1200 West Washington Street, Hearing Room 1, Phoenix, Arizona.

Copies of the documents filed in this matter are available on the internet via the Commission's website (www.azcc.gov) using the e-docket function. The documents are also available at the Commission's Docket Control office during regular business hours at 1200 West Washington, Phoenix, Arizona.
