Re: Docket No. T-20398A-06-0346 -- Request to withdraw previous requests for extension of time, and to cancel certificate

Dear Sir or Madam:

Navigator Telecommunications, LLC. ("Navigator") was granted a Certificate of Convenience and Necessity for authority to provide resold local exchange, facilities based local exchange and access telecommunications services in Arizona by the Commission in Docket No. T-20398A-06-0346, Decision No. 69884. To date, Navigator has not yet begun offering local exchange and access services in Arizona.

Navigator sought to reduce the bond requirement, which matter has been pending in Docket No. T-20398A-08-0463. Contemporaneously, Navigator, in this Docket No. T-20398A-06-0346, requested an extension of time necessary for the procurement of the bond, filing of a compliant tariff, and initiation of service, in order to allow the Commission time to consider the issues in Docket No. T-20398A-08-0463.

Because Navigator's request for a reduction of the bond requirement has been unsuccessful, Navigator has withdrawn all of its filings in Docket No. T-20398A-08-0463 and requested that said docket be closed.

Navigator hereby requests that its previously filed requests for extension of time in Docket No. T-20398A-06-0346 be withdrawn, and Navigator requests a cancellation of the certificate granted to it in Docket No. T-20398A-06-0346, Decision No. 69884. Because Navigator has never initiated the provisioning of local services in Arizona, no customers exist and no customers will be affected by this voluntary cancellation.

Please note that Navigator was granted a separate certificate to provide resold long distance services in Arizona in a separate Docket T-20398A-05-0551. Navigator intends to maintain that certificate, and does not intend to cancel or relinquish it at this time.
