Although most of the additional documents located in the electronic file folder are duplicative of documents previously produced by Cox, or submitted by Cox for in camera review, Cox hereby produces the non-privileged documents bearing document production numbers C04732-4761, C04770-4863, C04870-5383, C05385-5406..."

Is the reference in the email on C04761 to (1) the Appendix A included in pages C04800 to C04810; (2) the Appendix A included in pages C04811 to C04821; (3) to both Appendices included in pages C04800 to C04810 and C04811 to C04821; or (4) to another Appendix A?
