RE: THE APPLICATION OF JATCOM TELECOMMUNICATIONS-DATA. FOR AUTHORITY TO CANCEL ITS CERTIFICATE OF CONVENIENCE AND NECESSITY ("CC&N") FOR CUSTOMER OWNED PAY TELEPHONE ("COPT") PROVIDERS (DOCKET NO. T-04037A-09-0084)

On February 23, 2009, Jatcom Telecommunications-Data ("Jatcom" or "Applicant") filed an application with the Arizona Corporation Commission ("Commission") to cancel its Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay telephone ("COPT") service. The Commission granted Jatcom Telecommunications-Data a CC&N to provide COPT service in Decision No. 64834, dated May 16, 2002.

According to the application, the Applicant is the authorized person to make this request. The Applicant has also waived the right to a hearing and has waived the right to receive notices of a hearing in order to cancel the CC&N.

The Compliance Section of the Utilities Division indicates that the Applicant does not have any outstanding compliance issues that need to be addressed with the Commission. The Applicant has not been entered into the Compliance Database.

The Consumer Services section indicates that no complaints, opinions or inquiries have been filed against the company.

Staff recommends that the application to cancel the CC&N be approved. Upon cancellation of its CC&N, the Applicant will not be authorized to provide COPT telecommunications services in the state of Arizona. Therefore the Applicant will not be subject to any of the requirements of Decision No. 64834.
