**PROCEDURAL ORDER
GRANTING TEMPORARY
ADMISSION PRO HAC VICE**

BY THE COMMISSION:

Pursuant to Rule 38 of the Rules of the Supreme Court of Arizona, Douglas L. Kelly, on behalf of Wachovia Securities, LLC and Wachovia Capital Markets, LLC, has requested temporary admission *pro hac vice* in the above-captioned matter before the Arizona Corporation Commission ("Commission"). On March 16, 2009 the Motion and Consent of Local Counsel for Temporary Pro Hac Vice Admission of Douglas L. Kelly was filed with the Commission ("Motion"). Keith Beauchamp at Lewis and Roca, LLP has agreed to serve as designated local counsel for the above-captioned matter.

According to the request, Douglas L. Kelly desires to appear on behalf of his clients, Wachovia Securities, LLP and Wachovia Capital Markets, LLP at the Commission's Open Meeting scheduled for March 19, 2009. The Motion included a copy of the attorney's certificate of good standing from the state in which the attorney has been admitted to practice and a copy of the attorney's Application for Appearance *Pro Hac Vice* submitted to the State Bar of Arizona.

1 No objections to the Motion have been made.

2 Accordingly, for good cause shown and pursuant to Rule 38(a)3, the request for
3 temporary admission *pro hac vice* admission is reasonable and should be granted,
4 provided that the completion of the application procedures occurs within 45 days of this
5 procedural order.

6 IT IS THEREFORE ORDERED that the motion for temporary admission *pro hac*
7 *vice* of Douglas L. Kelly to appear before the Commission is hereby granted.

14 IT IS FURTHER ORDERED that withdrawal of representation must be made in
15 compliance with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct
16 (under Rule 42 of the Rules of the Arizona Supreme Court). Representation before the
17 Commission includes the obligation to appear at all hearings and procedural conferences,
18 as well as all Open Meetings for which the matter is scheduled for discussion, unless
19 counsel had previously been granted permission to withdraw by the Administrative Law
20 Judge.
