MODIFICATION OF BRIEFING

16 Qwest Corporation moves for an order modifying the briefing schedule regarding the
17 Motion for Summary Determination filed by Pac-West Telecomm, Inc. ("Pac-West"). The
18 current schedule established by the Procedural Order entered on January 26, 2009, provides that
19 Qwest and the Corporation Commission Staff ("Staff") shall file their responses to Pac-West's
20 Motion by March 30, 2009, and that Pac-West shall file its reply on April 20. Qwest asks that
21 the schedule be modified so that the responses of Qwest and of the Staff shall be filed on or
22 before April 9, 2009, and that the reply by Pac-West shall be filed on or before April 30, 2009.


23 Counsel for Pac-West and for Staff have authorized Qwest to represent that they do not
24 object to this Motion for Modification of Briefing Schedule.

25 Qwest seeks this modification because its counsel are litigating the same issues in three
26 jurisdictions including Arizona, and that those other jurisdictions have set briefing schedules that

1 require Qwest to file in the days before the Arizona brief is currently due. Qwest anticipated that
2 this scheduling congestion would occur but it turned out to be more severe than expected.
3 Accordingly, Qwest seeks the additional days stated above.
