NOTICE OF FILING

On December 29, 2008, Town of Sahuarita ("Town") filed an application for authorization to modify an existing railroad crossing at La Cañada Drive. Arizona Corporation Commission ("Commission") Railroad Safety Section Staff ("Staff") filed a staff report on February 24, 2009 evaluating the application. However, the Staff Report inadvertently did not include a service list of parties to whom the staff report had been mailed. On March 12, 2009, Administrative Law Judge Sarah Harpring issued a procedural order directing Staff by March 19, 2009 to:

file a document verifying that copies of the Staff Report have been provided to all persons appearing on the service list for this docket and stating the date/s those copies were provided. If Staff previously sent the Staff Report to the Town using the incorrect zip code, Staff shall ensure that the Staff Report is sent to the Town's correct address.

Staff member Chris Watson has personally called representatives of each party and confirmed receipt of the Staff Report. Staff has further directed representatives of the Town of Sahuarita to the Commission's e-docket for an electronic version.


