IN THE MATTER OF THE APPLICATION OF ARIZONA PUBLIC SERVICE COMPANY FOR A HEARING TO DETERMINE THE FAIR VALUE OF THE UTILITY PROPERTY OF THE COMPANY FOR RATEMAKING PURPOSES, TO FIX A JUST AND REASONABLE RATE OF RETURN THEREON, AND TO APPROVE RATE SCHEDULES DESIGNED TO DEVELOP SUCH RETURN.

PROCEDURAL ORDER

BY THE COMMISSION:

On March 24, 2008, Arizona Public Service Company ("APS") filed with the Arizona Corporation Commission ("Commission") an application for a rate increase.

By Procedural Order issued July 29, 2008, the hearing on the permanent rate application was scheduled to commence on April 2, 2009.

On January 23, 2009, APS filed a Notice of Settlement Discussions.

On January 30, 2009, APS filed a Motion to Suspend Procedural Schedule.

On February 4, 2009, a Procedural Order was issued which granted a 30 day extension and ordered that the parties make a filing prior to the end of the 30 day suspension period.

On March 5, 2009, APS filed a Motion to Further Suspend the Procedural Schedule and by Procedural Order dated March 6, 2009, the procedural schedule was suspended.

Accordingly, the March 25, 2009 procedural conference and the April 2, 2009 hearing date should be vacated, and a procedural conference should be scheduled to discuss the status of the settlement discussions and the procedural schedule in this matter. Additionally, because notice of the previously scheduled March 30, 2009 public comment session has already been published, it will be held as scheduled on March 30, 2009, however it may be necessary to hold an additional public comment session closer to the actual hearing date, once known.

1 IT IS THEREFORE ORDERED that the procedural conference currently set for March 25,
2 2009 and the hearing currently scheduled to begin on April 2, 2009, are hereby vacated.

3 IT IS FURTHER ORDERED that the **public comment session set for March 30, 2009 at**
4 **10:00 a.m.**, at the Commission's offices, 1200 West Washington, Hearing Room 1, Phoenix,
5 Arizona, **will proceed as scheduled**, and an additional public comment session may be scheduled for
6 a later date.

7 IT IS FURTHER ORDERED that a **procedural conference** shall be held on **April 7, 2009, at**
8 **10:00 a.m.**, at the Commission's offices, 1200 West Washington, Hearing Room 1, Phoenix,
9 Arizona, for the purpose of discussing the status of the settlement discussions and the procedural
10 schedule in this matter.


