PROCEDURAL ORDER

18 **BY THE COMMISSION:**

19 Docket Nos. E-01032C-98-0474 and E-01032C-97-0774 relate to the Arizona Corporation
20 Commission's ("Commission") consideration of Stranded Cost Recovery and Unbundled Tariffs for
21 Citizens Communications Company's Arizona Electric Division ("Citizens") pursuant to the
22 Commission's Retail Electric Competition Rules.

23 On July 3, 2003, in Decision No. 66028, the Commission approved the sale of assets and
24 transfer of the Certificate of Convenience and Necessity for Citizens' Arizona electric assets to
25 Unisource Energy Corporation. As a result, Citizens no longer provided electric service in Arizona.

26 IT IS THEREFORE ORDERED that Dockets Nos. E-01032C-98-0474 and E-01032C-97-
27 0774, shall be administratively closed. This Order does not affect Docket No. RE-00000C-94-
28 0165.


