PROCEDURAL ORDER
VACATING HEARING

12 BY THE COMMISSION:

13 On September 30, 2008, the Securities Division ("Division") of the Arizona Corporation
 14 Commission ("Commission") filed a Temporary Order ("T.O.") and Notice of Opportunity for
 15 Hearing ("Notice") against Randie Balbas and Leila Balbas, husband and wife (collectively
 16 "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act
 17 ("ACT") in connection with the offer and sale of securities in the form of promissory notes.

18 The Respondents were duly served with copies of the T.O. and Notice.

19 On October 16, 2008, a request for hearing was filed by the Respondents.

20 On October 17, 2008, by Procedural Order, a pre-hearing conference was scheduled on
 21 November 17, 2008.

22 On November 17, 2008, the Division and Respondents appeared through counsel. The parties
 23 are attempting to resolve the issues raised in the Notice. The Division and Respondents agreed on the
 24 scheduling of a status conference and that a hearing be scheduled in the event the issues raised in the
 25 Notice are not resolved.

26 On November 17, 2008, by Procedural Order, a hearing in this matter was set for April 6,
 27 2009, with April 7, 8, 9, and 10, 2009, set aside for additional days of hearing, if necessary.

28 On March 3, 2009, the parties filed a Stipulation Regarding Witness and Exhibit List setting


1 March 23, 2009, as the date to exchange witness and exhibit lists.

2 On March 19, 2009, the Commission approved an Order to Cease and Desist, Order of
3 Restitution, Order for Administrative Penalties and Consent to Same regarding Respondens Randie
4 Balbas and Leila Balbas.

5 On March 23, 2009, the Division filed a Motion to Vacate Hearing. Accordingly, for the
6 reasons set forth above, the Division's Motion to Vacate Hearing should be granted.

7 IT IS THEREFORE ORDERED that the **hearing on April 6, 2009**, as well as the dates of
8 **April 7, 8, 9, and 10, 2009, is hereby vacated.**


