SECOND PROCEDURAL ORDER

BY THE COMMISSION:

On February 18, 2009, the Securities division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and Notice of Opportunity for Hearing ("Notice") against Steve John Rogan, Carol Ann Richey, husband and wife, Dem Bonz Barbeque Restaurants, L.L.C. ("Dem Bonz") and Pizazz, L.L.C. ("Pizazz") (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of notes and for investment contracts.

The Respondents were duly served with a copy of the Notice.

On February 24, 2009, a request for hearing was filed by the Respondents.

On February 27, 2009, by Procedural Order, a pre-hearing conference was scheduled on March 23, 2009.

On March 23, 2009, the Division appeared with counsel and Respondents Rogan and Richey appeared on their own behalf. After the parties discussed the issues raised in the T.O. and Notice,

1 they agreed that a hearing be scheduled.

2 Accordingly, a hearing should be scheduled.

3 IT IS THEREFORE ORDERED that a **hearing** shall be held on **July 14, 2009, at 9:30 a.m.**,
4 at the Commission's offices, 1200 West Washington Street, Hearing Room 1, Phoenix, Arizona.

5 IT IS FURTHER ORDERED that the parties shall set aside **July 15, 2009, for an additional**
6 **day of hearing**, if necessary.

7 IT IS FURTHER ORDERED that the parties shall exchange copies of their **Exhibits and**
8 **Witness Lists** by **June 15, 2009**, with copies provided to the presiding Administrative Law Judge.
