BY THE COMMISSION:

On December 19, 2008, Far West Water & Sewer Company ("Far West" or "Company") filed with the Arizona Corporation Commission ("Commission") an emergency application for the immediate implementation of interim rates for sewer service, which rates would be effective until a decision has been issued on the Company's application for permanent rate increase.

By Procedural Order dated January 26, 2009, the matter was set for hearing to commence on April 6, 2009.

On March 11, 2009, Seth and Barbara Davis, residential customers of the Company, filed a Motion to Intervene.


