RE: Response to Staff's First Set of Data Requests to Copper Ridge Waste Water Facility ("Cooper Ridge" or "Company"), Docket No. SW-20628A-08-0493

Dear Ms Miller:

I just recently received a copy of your response dated March 3, 2009, to Staff's First Set of Data Request and my letter to you of February 25, 2009. In the future, please send correspondence directly to me (Vicki Wallace) at the Phoenix Office address listed at the bottom of this letterhead to avoid any delay in receipt.

You were asked in my letter of February 25, 2009, to respond to not only the 7 data requests but also to the information requested in the Insufficiency Letter dated October 23, 2008. Your response covered only the 7 data request questions and not the 23 items listed in the Insufficiency Letter. Thus, I am providing you a copy of that letter for response.

Additionally, the response to data request number three (stated below) was insufficient:

"According to azcentral.com and yumasun.com newspaper articles dated November 13, 2008, a federal grand jury in Phoenix returned a three-count indictment of falsifying test results against Nancy Miller (who is the management consultant for Copper Ridge) who ran Sunstate Environmental Laboratories ("Lab") that tested water samples for water companies, schools, and farms in Yuma and La Paz counties. One article indicated that Ms. Miller agreed to close Lab until after a state investigation. Please explain Ms. Miller's involvement with the Lab, the allegations against her, and the status of the case."

Your response to the above-referenced data request was "This case is pending. No conviction or court ruling has occurred to date." Please explain Ms. Miller's involvement with the Lab and the allegations against her.

If the applicant does not provide the requested information in this data request and the data requested in the Insufficiency Letter within 30 calendar days of your

receipt of this letter, the Staff may pursue an Order to Show Cause or other remedies against the owners of Copper Ridge for construction of wastewater facilities prior to ACC approval which is a violation of A.A.C. R14-2-602.A.1.
