PUBLIC NOTICE OF AN APPLICATION FOR AN ORDER

AUTHORIZING THE ISSUANCE OF \$4,694,523 long-term debt by Sahuarita Water Company.

Sahuarita Water Company, L.L.C. ("Company") filed an Application on March 13, 2009 with the Arizona Corporation Commission ("Commission") for an order authorizing Applicant to issue \$4,694,523 of long-term debt in order to finance the construction of water system facilities. The Application is available for inspection during regular business hours at the offices of the Commission in Phoenix, Arizona, Tucson, Arizona and the Company's offices at 725 W. Via Rancho Sahuarita in Sahuarita, Arizona, 85629. The Application has been assigned Docket No. W-03418A-09-0122.

Intervention in the Commission's proceedings on the Application shall be permitted to any person entitled by law to intervene and having a direct and substantial interest in this matter. Persons desiring to intervene must file a Motion to Intervene with the Commission which must be served upon the Company and which, at a minimum, shall contain the following information:

1. The name, address and telephone number of the proposed intervenor and of any person upon whom service of documents is to be made if different than the intervenor.
2. A short statement of the proposed intervenor's interest in the proceeding.
3. Whether the proposed intervenor desires a formal evidentiary hearing on the application and the reasons for such a hearing.
4. A statement certifying that a copy of the Motion to Intervene has been mailed to Applicant.

The granting of Motions to Intervene shall be governed by A.A.C. R14-3-105, except that all Motions to Intervene must be filed on, or before, the 15th day after this notice.
