PROCEDURAL ORDER

**BY THE COMMISSION:**

On March 12 2009, Chaparral City Water Company, Inc. ("CCWC") filed with the Arizona Corporation Commission ("Commission") the above-described application for financing authority.

On April 10, 2009, CCWC filed a Notice of Withdrawal ("Notice"). In the Notice, CCWC states that the application was filed as a pre-requisite to CCWC's application to the Water Infrastructure Financing Authority ("WIFA") for funding of the proposed infrastructure project. The Notice states that WIFA recently informed CCWC that the proposed project did not make WIFA's final list of projects in Arizona for receipt of stimulus funds made available by the American Recovery and Reinvestment Act of 2009. CCWC therefore no longer wishes to receive financing authority for the proposed project.

Accordingly, this docket should be administratively closed.


