19 Public comment will be taken during the hearing at times designated by the Chairman. Additional days
20 for the hearing may be set, or the hearing may conclude earlier than anticipated, depending upon the
21 number of parties that intervene, the amount of testimony presented, the amount of public comment,
22 and the time needed for deliberations by the Committee. As a part of the public meeting/hearing,
23 members of the Committee will discuss the potential value of a tour, and, at the discretion of the
24 Chairman of the Committee, may tour the proposed route for the project on a future date to be set by
the Chairman of the Committee at the meeting/hearing. At the meeting/hearing, the Committee may
consider, discuss, deliberate and/or vote on the matters on the Agenda. Items on the Agenda may be
taken in a different order than listed as conditions require.




