**STAFF'S RESPONSE TO
REQUEST FOR EXTENSION**

Arizona Corporation Commission Staff ("Staff") hereby responds to the Beaver Dam Water Company, Inc.'s ("Beaver Dam" or "Company") request for an extension filed in the above-named consolidated dockets on April 13, 2009.

Staff filed its Staff report in this matter on April 7, 2009. The Hearing Division procedural order issued on January 23, 2009, directed that Beaver Dam file a written response to that Staff report on or before April 17, 2009. Beaver Dam now requests that its deadline for filing a response be extended seven days, until Friday, April 24, 2009. The hearing in this matter is scheduled for Monday, April 27; therefore, granting the Company's requested extension would deprive Staff of the opportunity to review the filing prior to the hearing. However, Staff has no objection to extending the Company's deadline until Wednesday, April 22, 2009. This would allow Staff two days to review the Company's response and still allow the hearing to proceed as scheduled on April 27.
