PROCEDURAL ORDER

BY THE COMMISSION:

At Open Meeting held on August 1, 2000, the Arizona Corporation Commission ("Commission") ordered the Utilities Division Staff ("Staff") to forward a new section to the Retail Electric Competition Rules (A.A.C. R14-2-1601 et seq.) entitled the Environmental Portfolio Standard, to be numbered as A.A.C. R14-2-1618 to the Office of the Secretary of State for Notice of Proposed Rulemaking. In the Decision issued pursuant to the August 1, 2000 Open Meeting, the Commission also ordered the Hearing Division to issue a Procedural Order scheduling oral proceedings on this matter. Accordingly, this Procedural Order establishes a public comment hearing date and a schedule for the submission of both initial written comments and responsive written comments prior to the public comment hearing.

IT IS THEREFORE ORDERED that a public comment hearing on the above-captioned matter shall be held on November 9, 2000 commencing at 10:00 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona 85007.

IT IS FURTHER ORDERED that all interested parties are requested to file written comments on or before 4:00 p.m. on October 5, 2000.


