
REQUEST FOR EXTENSION

Rhythms Links Inc. ("Rhythms") is an intervenor in this proceeding. Rhythms' prefiled direct testimony is due on December 11, 2000. Unfortunately, Rhythms did not receive a copy of Qwest testimony until November 8, 2000, rather than October 11, 2000 as contemplated by the August 21, 2000 Procedural Order.
