PROCEDURAL ORDER

14 **BY THE COMMISSION:**

15 On March 7, 2009, the Securities division ("Division") of the Arizona Corporation
16 Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and Notice of
17 Opportunity for Hearing ("Notice") against Sports Dimensions, Inc. ("SDI") and Marc Hubbard and
18 Jane Doe Hubbard, husband and wife (collectively "Respondents"), in which the Division alleged
19 multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of
20 securities in the form of notes.

21 The Respondents were duly served with a copy of the T.O. and Notice.

22 On April 24, 2009, an Answer was filed by the Respondent, Marc Hubbard, and while he did
23 not specifically request a hearing, his filing of an Answer will be treated as satisfying the
24 requirements of A.R.S. § 44-1942 and A.C.C. R14-4-307 for the purpose of requesting a hearing.

25 Accordingly, a pre-hearing conference should be scheduled.

26 IT IS THEREFORE ORDERED that a **pre-hearing conference** shall be held on **May 14,**
27 **2009, at 9:30 a.m.,** at the Commission's offices, 1200 West Washington Street, Room 100, Phoenix,
28 Arizona.

1 IT IS FURTHER ORDERED that Mr. Hubbard may appear telephonically at this
2 proceeding if he wishes to do so.

3 IT IS FURTHER ORDERED that if Mr. Hubbard wishes to appear telephonically, he
4 shall contact the Hearing Division at (602) 542-4250 at least five days prior to the pre-hearing
5 conference for instructions on how to appear telephonically.

6 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
7 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission
8 *pro hac vice*.

9 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
10 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
