

**PROCEDURAL ORDER**

9 **BY THE COMMISSION:**

10 By Procedural Order dated February 15, 2001, we established a schedule for filing  
11 testimony and set a date for the arbitration on Phase II of this proceeding. By Procedural Order  
12 issued April 19, 2001, we set additional time deadlines, including the following:

13  
14 IT IS FURTHER ORDERED that discovery shall be as permitted by law and  
the rules and regulations of the Commission, except that: until June 15, 2001,  
15 responses to and any objections to discovery requests shall be made within 10  
16 days<sup>1</sup> of receipt; thereafter, responses to and objections to discovery requests  
shall be made within 5 days<sup>1</sup>; the response time may be extended by mutual  
17 agreement of the parties involved if the request requires an extensive  
compilation effort. <sup>1</sup> "Days" means calendar days.

18 The parties had reached consensus that "Days" would mean "business days", but the  
19 Procedural Order inadvertently referred to "calendar days". Accordingly, the April 19, 2001  
20 Procedural Order should be amended to define "Days" as business days.

21 IT IS THEREFORE ORDERED that the April 19, 2001 Procedural Order is hereby amended  
22 to define "Days" as business days.

1 IT IS FURTHER ORDERED that the Arbitrator(s) may rescind, alter, amend, or waive any  
2 portion of this Procedural Order either by subsequent Procedural Order or by ruling at arbitration.


