11 Phoenix, Arizona.


12 IT IS FURTHER ORDERED that the Commission's Utilities Division ("Staff") shall file by
13 **May 7, 2009**, a memorandum in this Docket indicating which, if any, of the above-named
14 Respondents have filed 2007 Annual Reports since the issuance of Decision No. 70964.

15 IT IS FURTHER ORDERED that the **hearing on the OSC shall be held on May 22, 2009 at**
16 **10:00 a.m.**, or as soon thereafter as is practicable, at the Commission's offices, 1200 West
17 Washington Street, Room 100, Phoenix, Arizona.

18 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
19 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission *pro*
20 *hac vice*.

21 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
22 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
23 hearing.


