1 ALJ STERN: Let's go on the record in the matter
2 of Jerome William Carter, et al. This is Docket
3 No. S-20625A-08-0481.

4 My name is Marc Stern, and I will preside over
5 the proceeding today. And at this time we will take
6 appearances.

7 And on behalf of the Division?

8 MR. BLACK: Judge, on behalf of the Division,
9 William Black.

10 ALJ STERN: And I will note on the record that
11 apparently -- I think I have seen Mr. Carter once.

12 And, Mr. Carter, are you here?

13 (No response.)

14 ALJ STERN: Mr. Carter is not here and has not
15 informed us that he could not be here for any reason.
16 So --

17 Oh, Mr. Carter.

18 MR. CARTER: My apologies. I do have a
19 reasonable excuse, but thank you.

20 ALJ STERN: We were waiting. I just got on the
21 record, but I can give you a few minutes. So since you
22 just got here, let's take a brief recess for you. It
23 looks like you are out of breath.

24 I don't know if you want to talk to Mr. Black at
25 all. Maybe a resolution is possible before we spend four

1 or five days in a hearing.

2 So we will take a recess for a few minutes, and I
3 will come back in about ten minutes. If you want me
4 beforehand, I guess you could call me.

5 (Whereupon, a recess was taken from 10:27 a.m.
6 until 11:13 a.m.)

7 ALJ STERN: Back on the record.

8 We will note for the record Mr. Carter is
9 present.

10 Mr. Black, what is the status of the situation
11 presently?

12 MR. BLACK: Judge Stern, I have a signed consent
13 by Mr. Carter, but I wanted to go back the record to
14 note -- so you could note Mr. Carter had appeared.

15 ALJ STERN: Okay. What I'm going to suggest then
16 is that we recess this matter pending your submission of
17 the consent order to the Commission for approval. At that
18 point then, if the matter is taken and approved by the
19 Commission, you can just file to vacate the proceeding,
20 and that will be the end of it.

21 I will not schedule any pending proceedings
22 pending that.

23 MR. BLACK: Okay.

24 ALJ STERN: Thank you.

25 Thank you, Mr. Carter. Sorry you had problems

1 getting down here today, and I appreciate your agreeing to
2 resolve the matter.

3 We are off the record. That concludes today's
4 proceeding.

5 MR. CARTER: Thank you.

6 MR. BLACK: Thank you, Judge.
