9 Little Park Water Company, Inc. ("Little Park" or the "Company"), by and through
10 undersigned counsel, hereby files its Motion for Final Order in accordance with Decision No.
11 70208 dated March 20, 2008, as amended by Decision No. 70612, dated November 19, 2008, and
12 in support of said Motion states as follows:

- 13 1. Decision No. 70208, requires, among other things, four compliance items as
14 follows:
15 a. By May 1, 2008, file either; (i) an application for approval of WIFA funding for
16 the Arsenic Treatment Plants (the "ATP's"), or (ii) a document evidencing an
17 equity infusion for that purpose; and.
18 b. By June 1, 2008, (as modified to August 31, 2008 by a Procedural Order dated
19 June 20, 2008) to file an Arizona Department of Environmental Quality's
20 ("ADEQ's") Approval to Construction ("ATC") for the ATP's for both well sites;

1 c. By June 30, 2009, file; (i) Approvals of Construction (“AOC’s”) for the ATP’s at
2 the two existing wells, and (ii) an AOC for the on-site facilities to serve the
3 expansion area; and

4 d. By May 1, 2010, file a letter showing the water sales within the expansion area
5 are being reported to the Arizona Department of Water Resources (“ADWR”),
6 and (ii) a letter from ADWR confirming that the Company’s Designation of
7 Assured Water Supply was still in effect.

8 2. The Company complied with Compliance Item 1(a) by filing an Affidavit to that
9 effect on May 1, 2008.

10 3. The Company complied with Compliance Item 1(b) by filing those documents on
11 June 20, 2008.

12 4. The Company complied with Compliance Item 1(c) (i) by filing the ATC for Well
13 #1 on December 17, 2008, and the ATC for Well #2 on January 13, 2009.

14 5. The compliance requirement for Compliance Item 3 (c) (ii) was eliminated by
15 Decision No. 70612.

16 6. The compliance requirement for Compliance Item 3 (d) (i) was eliminated by
17 Decision No. 70612.


18 7. The Compliance requirement for Item (d) (ii) was filed under separate cover of
19 even date herewith.

20 8. Based on the Compliance Item filings as set forth in Paragraphs 2 through 7
21 above, the Company represents that it has complied with all requirements of Decision No. 70208
22 as amended by Decision No. 70612.

1 WHEREFORE, Little Park respectfully requests that in accordance with Decision No.
2 70208, the Staff verify such filings as satisfying all compliance requirements consistent with
3 Decision Nos. 70208 and 70612, and thereafter prepare and docket for Commission approval a
4 Final Order for approval of the extension of the Certificate of Convenience and Necessity for the
5 area set forth in Exhibit A to Decision No. 70208.


