RE: **UPDATE** - IN THE MATTER OF THE APPLICATION OF CORDIA COMMUNICATIONS, CORPORATION FOR APPROVAL OF A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE RESOLD LONG DISTANCE AND FACILITIES-BASED LOCAL EXCHANGE TELECOMMUNICATIONS SERVICES (DOCKET NO. T-20439A-06-0076)

On February 8, 2006, Cordia Communications Corporation ("Cordia" or "Applicant") filed an Application for a Certificate of Convenience and Necessity to provide resold long distance and facilities-based local exchange telecommunications services within the State of Arizona. On February 8, 2006, Cordia also submitted a proposed tariff for the services it is requesting the authority to provide.

On March 1, 2006, Staff filed a Letter of Insufficiency and issued its First Set of Data Requests to Cordia. Subsequent to that date, Staff sent the applicant its Second, Third and Fourth Sets of Data requests, the latest having been sent on February 4, 2009. On April 6, 2009, the Hearing Division issued a Procedural Order requiring that Staff provide an update on this matter by May 22, 2009.

On April 15, 2009, Cordia filed its responses to Staff's Fourth Set of Data Requests with an indication that a CD was attached containing spreadsheets. Staff contacted Cordia via email to request a copy of the CD that was missing from Cordia's responses. On April 20, 2009, Cordia's General Counsel emailed the spreadsheet file to Staff.

Staff is in the process of reviewing Cordia's responses and the above-mentioned spreadsheets. Staff recommends that this docket remain open.
