**STAFF'S RESPONSE TO APPLICATION  
TO CHANGE NAME**

10 The Arizona Corporation Commission Staff ("Staff") has reviewed the application of 'Joseph  
 11 M. Blanchette d/b/a The Antigua Group, Inc.' ("Company") to change its name to 'The Antigua  
 12 Group, Inc.' Staff does not oppose the request of the Company to change its name. However, it  
 13 appears that the Company may have been incorrectly referred to as 'Joseph M. Blanchette, d/b/a The  
 14 Antigua Group, Inc.' in Decision No. 65980.<sup>1</sup> The Company explained to Staff that Joseph M.  
 15 Blanchette was merely the employee of the Company who filed the original Application For  
 16 Adjudication Not A Public Service Corporation and Certificate of Convenience and Necessity to  
 17 provide customer-owned pay telephone service in the State of Arizona in Docket No. T-04067A-01-  
 18 0912. The Company also informed Staff that Mr. Blanchette was never the owner of the Company  
 19 and is no longer an employee of the Company. Staff therefore supports the Company's request to  
 20 change its name to 'The Antigua Group, Inc.' or any other resolution the Commission deems  
 21 appropriate in relation to this docket or Docket No. T-04067A-01-0912.
