Pursuant to Decision 69949 (October 30, 2007), Baca Float Water Company, Inc. ("Baca Float" or the "Company") is required to file a rate case by May 31, 2009, using a 2008 test year. On April 15, 2009, Baca Float filed a Motion for Extension of Time to File Rate Case (the "Motion"). Baca Float needed the extension because its certified public accountant, who was responsible for preparing numerous tax returns for filing by the April 15, 2009 tax deadline, was not able to assist the Company in preparing its rate case application until the tax season ended. The accountant's familiarity with the Company's operations makes him a critical participant in preparing the rate case application. Thus, to ensure that Baca Float's application is accurate and complete, the Company requested a short extension of the rate case filing deadline through and including July 31, 2009.

The Motion was filed more than 30 days ago, and the Utilities Division Staff has not responded to the Motion, nor has a procedural order been issued regarding the
