Having considered the entire record herein and being fully advised in the premises, the Commission finds, concludes, and orders that:

FINDINGS OF FACT

- In Commission Decision No. 64834 (May 16, 2002), the Arizona Corporation Commission ("Commission") granted James A. Tyler dba Jatcom Telecommunications-Data ("Jatcom") a Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay telephone ("COPT") services in Arizona.
- On February 23, 2009, Jatcom filed an application with the Commission requesting cancellation of its CC&N to provide COPT services in Arizona.
- According to the application, Jatcom is not conducting business or providing services to customers in Arizona.
- Jatcom has no outstanding compliance issued filed with the Commission.
- The Commission's Consumer Services Section indicates that no complaints, opinions or inquiries have been filed against Jatcom.
