Introduction

On May 29, 2009, Oak Creek Water Company No. 1 ("Oak Creek" or the "Company") filed for an Off-site Facilities Hook-up Fee ("OFHF") Tariff for the Commission's approval.

The Company proposed the subject OFHF tariff to help pay for a new storage tank, booster pump station upgrades, installation of new mains, and other miscellaneous upgrades.

The Company seeks approval of a \$2,500 fee for all new 5/8-inch service connections served by the Company's water facilities located in the City of Sedona, Yavapai County, Arizona.

Suspensions of Tariff
